Submit your pre-application now...

A pre-application provides an initial project overview to assess eligibility and alignment with ARC priorities, offering feedback to refine proposals before full application.



Items to address early:

Federal Unique Entity Identifier (UEI)

Required for all federal funding applications, ensuring your organization is properly register in the System for Award Managment.

Letter of Alignment

Letter from the County Planning Directors in the counties served is required. This ensures that the project is also in alignment with local planning goals.
